Your regular giving supports the local ministry of our congregation.

Donors can choose more than one fund. In addition to regular givings you can choose other funds such as PWSD or the Benevolent Fund to support other ministries in Canada and around the world.

How to Participate

1. Prayerfully decide what you will give each year, and divide that amount by 12.
2. Fill out the authorization form, and attach a cheque marked "VOID."
3. Enclose both in an envelope and place on the offering plate, give to our designated PAR contact person, or leave at the church office.
4. The amount will be transferred from your account to our congregation's account on the 20th of each month. You can modify or cancel your donation, change how it is designated, or change your information at any time.
5. Making an offering is an important part of our worship time together. We will give you PAR cards to place on the offering plate as a symbol of your gift.
